In March 2018, Medibank/HEalthStrong introduced FamilyFlex- a new approach to parental leave for employees.

Medibank removed all references to primary and secondary care from our policies- ALL parents at Medibank/HealthStrong are now entitled to a full 14 weeks paid parental leave, regardless of the role they play in child

rearing. Employees are also able to take their 14 weeks leave flexibly within the first 2 years of the child's birth, across 2 distinct periods, if that suits their needs. We also reduced the eligibility period to 6 months after commencing employment.

This is all in addition to our existing supports- Medibank's parental leave support suite is aimed at supporting parents (men and women) during their pregnancy/adoption process, to prepare for parenthood, and to ease the transition onto parental leave and then back into the workplace. The suite includes:

- A parental leave guide, which provides checklists and advice to employees across the parental leave process, including how to manage their health and wellbeing;

- A mobile-first Parental Leave Navigator program, which connects people leaders and employees throughout the parental leave process via reminders, check-ins and just-in-time resources; and

- Executive Coaching on managing parental leave transitions
