## Notice of Intention

Proposed transfer of the direct life insurance business of Swiss Re Life & Health Australia Limited ABN 74000218306 (Swiss Re Life) to Hannover Life Re of Australasia Ltd ABN 37062395484 (Hannover Life)

Swiss Re Life and Hannover Life give notice of their intention to make an application to the Federal Court of Australia (**Federal Court**) for confirmation of a scheme under Part 9 of the *Life Insurance Act 1995* (Cth) to transfer the life insurance business of Swiss Re Life's Statutory Fund No.1 to Hannover Life's Australian Statutory Fund (**Scheme**). The proposed effective time of the transfer is 12.01am on 1 December 2025 (**Effective Time**).

The application is scheduled to be heard by the Federal Court at 9:15am on 14 November 2025, or on such other time or date as the Federal Court appoints, at the New South Wales Registry of the Federal Court, located in the Law Courts Building, Queens Square, Sydney.

Policy owners affected by the Scheme have the right to attend the Federal Court hearing and can request to be heard by the Federal Court.

If the Scheme is confirmed by the Federal Court, then it is proposed that with effect from the Effective Time, Hannover Life will assume all of Swiss Re Life's rights and liabilities in relation to all life insurance policies referable to Swiss Re Life's Statutory Fund No.1. The contractual benefits and rights of Swiss Re Life policy owners under these life insurance policies will remain unchanged other than:

- a change to the insurer from Swiss Re Life to Hannover Life; and
- a change to the statutory fund that supports each policy owner's life insurance policy.

## If you are affected by the Scheme

Any policy owner who may be affected by the Scheme is entitled to attend the Federal Court hearing and request to be heard on the application.
